2022 NACSA LEADERSHIP CONFERENCE VACCINATION POLICY

NACSA values and prioritizes the health and safety of all our participants, speakers, and staff and, as such, NACSA will follow any federal, state, and local ordinances as well as best practices in connection with NACSA's 2022 Annual Conference (NACSACon).

COVID-19 Vaccination Requirements

All registered participants, attendees, vendors and guests of the in-person NACSA Annual Conference (NACSACon) in Minneapolis, Minnesota are required to be "Up to Date" in their vaccinations against COVID-19* unless they are eligible for an exemption.** This policy is for the safety and welfare of our attendees and based on guidance and recommendations issued by the Centers for Disease Control and Prevention (CDC) and other public health authorities and applies to all events and meetings in connection with NACSACon.

NACSA is committed to helping participants feel safe and comfortable during NACSACon to maximize the opportunity for real-time engagement and connection with peers and colleagues. All NACSACon participants are expected to adhere to and abide by the health and safety protocols established by NACSA in order to protect against the spread of COVID-19 (NACSACon Health and Safety Protocols). I acknowledge that to attend this event I have read the <u>NACSACon Health and Safety Protocols</u>, that I must show proof of <u>full vaccination</u> against COVID-19, and proof that they have tested negative for COVID -19 via a covid test taken within 72 hours of arrival on site for NACSACon. I also agree to adhere to any health and safety protocols, I will not be granted admittance to attend NACSACon and that I may be removed from NACSACon without refund of registration fees understand that NACSACon Health and Safety Protocols all NACSA policies are subject to change upon notice from NACSA.

All attendees (registrants, presenters, guests, sponsors, staff and vendors) will be required to provide proof that they are "Up to Date" in their vaccinations against COVID-19* unless they receive an approved exemption. NACSA will be providing directions to attendees on how to submit proof of COVID-19 vaccination status closer to the start of NACSACon.

Attendees who do not have an approved exemption will not be able to check-in and receive their badge without having submitted proof of their vaccination status as directed by NACSA prior to arrival at the event.

Protocol Communications

NACSA will communicate safety protocols prior to the NACSACon, e.g., masking, social distancing, etc. All participants must follow safety protocols and directives at all events and meetings. Further, all attendees will also be required to submit a Safety Information and Waiver Form which will be provided along with information on how to submit proof of vaccination status.

Please note that NACSA may modify these requirements upon notice to attendees. Thank you in advance for your cooperation and support of our efforts to create a safe experience for everyone.

*Up to date means a person has received all recommended COVID-19 vaccines, including any booster dose(s) when eligible. Please see the CDC website for additional information.

** To request an exemption from the COVID-19 vaccination requirement due to a health circumstance or sincerely held religious belief, please contact conference@qualitycharters.org to request the required form that will need to be completed. Individuals granted an exemption must still provide proof electronically that they have tested negative for COVID-19 via a PCR COVID-19 test (verified by a healthcare provider) no more than 48 hours prior to their arrival at the NACSACon Registration Area. Attendees will be responsible for arranging and paying for any such tests.
